An attorney and certified public accountant, Brian was formerly legislative counsel to the US Congress Joint Committee on Taxation, where he provided policy and technical analysis relating to pensions and employee benefits, health care, Social Security and worker classification to members of Congress and their staffs. Brian also participated in the drafting of statutory language for Congress, including substantial portions of the Small Business Job Protection Act of 1996 and the Health Insurance Portability and Accountability Act of 1996. Prior to working on Capitol Hill, Brian was associated with the Washington, DC law firm of Groom and Nordberg, Chtd., which specializes in employee benefits.

Brian served as a delegate to the White House/Congressional National Summit on Retirement Savings. He is also a member of US Chamber of Commerce Employee Benefits Committee and serves on the Board of the Small Business Council of America.

Brian received his doctoral degree in law cum laude from the University of Pennsylvania Law School. He holds a Bachelor of Science in Accounting with distinction from Cornell University in Ithaca, NY.
